**DANGEROUS GOODS**

TK Logistik handles the consignments in accordance with current regulations (ADR / RID / IMDG code) in a legal manner. At the time of booking, TK Logistik must be informed of the dangerous goods. The booking is confirmed by TK Logistik if the assignment can be performed.

The consignor is responsible for declaring the goods and attaching documents in accordance with the applicable regulations (ADR / RID / IMDG code). Each package must be marked with regular labels.

For ADR goods Class 1, 6.2 and Class 7, transport takes place in order traffic by special agreement. Price agreement is reached at each individual transport occasion. For Dangerous Goods transports, deviations from the Transport Schedule can occur. For shipping containing Dangerous Goods, a supplement is charged. When loading dangerous goods, loading and securing of cargo apply in accordance with applicable transport regulations (ADR-S, ADR, RID, IMDG). Materials for eg classification of goods are provided by the sender.
