In the event of notification, NOTIFICATION must be clearly stated on the consignment note/booking together with the recipient's telephone number (daytime). TK Logistik will contact the recipient and inform them of the delivery date (according to the current schedule) An extra lead time will be added when booking the notification.

DANGEROUS GOODS

TK Logistik handles the shipments in accordance with current regulations (ADR/RID/IMDG code) in a legal manner. TK Logistik must be informed about the dangerous goods at the time of booking. The booking is confirmed by TK Logistik if the assignment can be carried out.

The shipper is responsible for declaring the goods and attaching documents in accordance with the applicable regulations (ADR/RID/IMDG code). Each package must be marked with regular labels. For ADR Goods Class



1, 6.2 and Class 7 are transported in chartered traffic by special agreement. Price agreements are made on each individual transport occasion. For Dangerous Goods transports, deviations from the Transport Schedule may occur. A surcharge will be charged for consignments containing Dangerous Goods. When loading dangerous goods, loading and cargo securing applies in accordance with the applicable transport regulations (ADR-S, ADR, RID, IMDG). Material for e.g. classification of goods is provided by the sender.
